**Vegetables and Row Crops - Foliar:** Use 3 to 6 quarts per acre in enough water to provide adequate coverage. Begin at full bloom, apply at 10 to 14 day intervals. **Fertigation:** Apply 1 to 2 gallons per acre per application. Use 3 to 6 times during the growing season.

**Citrus and Fruit Crops - Foliar:** Use 5 to 10 quarts per acre in enough water to provide uniform coverage. Start at early bloom, repeat after fruit set. **Fertigation:** Apply 2 to 5 gallons per acre per application. Apply as needed.

**Lawns, Turf, Golf Courses:** Application rates are calculated of Lbs for Nitrogen (N) / 1,000 square feet: **0.05 Lbs N: 3.8 oz 0.10 Lbs N: 7.6 oz 0.25 Lbs N: 19 oz** Apply with sufficient water to ensure thorough coverage. Compatible with most chemicals and other fertilizers. A jar test is recommended when mixing unfamiliar products. **DO NOT** mix with acidic or calcium products.
